O. Effect of Supplement

This supplement provides for the addition of the following indications for ferrets: MidamoxTM for Cats is indicated for the prevention of heartworm disease in ferrets caused by *Dirofilaria immitis*. MidamoxTM for Cats kills adult fleas (*Ctenocephalides felis*) and is indicated for the treatment of flea infestations on ferrets.

II. BIOEQUIVALENCE

CVM did not require additional bioequivalence information for this supplemental approval. The FOI Summary for the original approval of ANADA 200-721, dated March 28, 2022, contains a summary of the basis for granting a biowaiver for the generic drug product Midamox[™] for Cats (imidacloprid + moxidectin) topical solution.

III. HUMAN FOOD SAFETY

This drug is intended for use ferrets. Because this new animal drug is not intended for use in food-producing animals, CVM did not require data pertaining to drug residues in food (i.e., human food safety) for approval of this ANADA.

IV. USER SAFETY

The product labeling contains the following information regarding safety to humans handling, administering, or exposed to Midamox[™] for Cats:

HUMAN WARNINGS:

Not for human use. Keep out of the reach of children. Children should not come in contact with the application site for 30 minutes after application.

Causes eye irritation. Harmful if swallowed. Do not get in eyes or on clothing. Avoid contact with skin. Exposure to the product has been reported to cause headache; dizziness; and redness, burning, tingling, or numbness of the skin.

Wash hands thoroughly with soap and warm water after handling.

If contact with eyes occurs, hold eyelids open and flush with copious amounts of water for 15 minutes. If eye irritation develops or persists, contact a physician. If swallowed, call poison control center or physician immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by

the poison control center or physician. People with known hypersensitivity to benzyl alcohol, imidacloprid or moxidectin should administer the product with caution. In case of allergic reaction, contact a physician. If contact with skin or clothing occurs, take off contaminated clothing. Wash skin immediately with plenty of soap and water. Call a poison control center or physician for treatment advice.

V. AGENCY CONCLUSIONS
